On-farm Solutions: Farmer Terms and Conditions



The following terms and conditions apply to any farm that Fonterra has deemed eligible to participate in the 'On-farm Solutions' initiative (the 'Initiative') and receive funding towards solutions included in the Initiative (the 'Funding'). By accepting these terms and conditions, you acknowledge and accept:

- To participate in the Initiative and be considered eligible for the Funding, you will achieve any level of The Cooperative Difference in the 2025/2026 season.
- You will need to meet, and continue to meet, the Fonterra Farmers' Terms of Supply for the duration of the 2025/2026 season.
- By submitting a Funding application form and accepting these terms, you are merely confirming your interest in participating in the Initiative. A binding commitment to receive the Funding will only occur if and when Fonterra provides written confirmation that your Funding application has been accepted.
- By submitting a Funding application form, in addition to agreeing to these Funding terms with Fonterra, you are also agreeing to be bound by the applicable vendor terms and conditions for the solution you have selected on the application form. These terms and conditions will be provided by vendors when you sign up to receive a solution. Please make sure you have read and understood the vendor's terms and conditions before submitting your application to participate in the Initiative.
- Notwithstanding any confirmed eligibility to receive Funding, you remain liable for all vendor costs associated with your chosen solution, and Fonterra will not bear any financial liability to a vendor on your behalf under any circumstances from your participation, or the termination of your participation, in the Initiative. The Funding is paid as reimbursement to you in recognition of your use of a selected solution by the supply number set out in the application.
- The total volume of Funding across all solutions is capped, and vendor capacity to deliver the particular solutions may be limited.
- Applications are limited to one per supply number per season. If multiple applications are submitted, only the first application received will be considered for Funding.
- Your contact details and other information provided in the Funding application form will be provided to the applicable vendor(s) to confirm your eligibility to participate in the Initiative.
- Confirmation of Funding applied to your milk cheque will be emailed to you once we have verified your
 engagement with each solution. If your application is successful, you are expected to reach out to the vendors to
 book in the solution of your choice, if our vendors do not hear from you they may use the information provided in
 this form to contact you regarding scheduling your solution or onboarding you to their solution (if you are not
 already onboarded), and once confirmed with the vendor, you will receive a Funding confirmation email from
 Fonterra.
- If your chosen solution is not booked by 30 November 2025, your Funding will be considered withdrawn and will be redistributed back into the customer funding pool.
- If you are allocated Funding for a subscription-based solution, you are expected to continue that subscription until you have exhausted the Funding provided.

- If your application is accepted, the vendor terms and conditions applicable to the solution you receive Funding for will apply (as between you and the vendor). You are solely responsible for evaluating the solutions and committing yourself to using the solution on your farm. Fonterra makes no representations or warranties (whether express or implied) as to whether a selected solution is fit for purpose in your circumstances.
- Except for the commitment to provide the Funding (which will be strictly limited to the amount and for the duration
 as set out in any Funding confirmation you receive from Fonterra, as relevant), any rights, obligations and/or
 liabilities regarding your use of the solution will be between you and the vendor, and governed by the applicable
 vendor terms and conditions (for example, Dairy Herd Testing Standards). Fonterra makes no representation or
 warranty that any solution is fit for purpose in your circumstances and/or will deliver any particular outcome. You
 are solely responsible for evaluating the solutions included in the Initiative and deciding to purchase / use a
 particular solution on your farm.
- For solutions that have a variable cost, the Funding we agree to provide will be capped at \$1,500 (ex. GST) per supply number. Funding can only be applied to the solutions specified as 'Funded Solutions' as detailed in table 1 below, and excludes any add-ons to such solutions, including but not limited to herd test assists, field assists, EZ link devices.
- The Funding contribution will appear as a rebate/credit to your monthly milk statement, the month following verification of your invoice between the vendor and Fonterra. Where the cost of the solution exceeds \$1,500 (ex. GST), you will only be reimbursed to the limit of \$1,500 (ex. GST). Where the cost of the tool is less than \$1,500 (ex. GST), you will be credited by Fonterra for the amount spent on the solution.
- Delivery of the solution to you will be managed by the vendor, therefore depending on uptake, there may be some delay in the delivery or access to the solution.
- In addition to any rights a vendor may have to share your data under the applicable vendor terms and conditions, you also agree that the vendor of any solution has permission to share the Data Points outlined in the table below with Fonterra for the Purpose specified. Any data shared by the vendor and received by Fonterra will be managed by Fonterra in accordance with section 4 of the Fonterra Farmers' Terms of Supply.
- You may be asked to provide feedback (with reasonable notice) on the solution you have received Funding for. You agree to provide reasonable assistance, feedback, and cooperation as requested to facilitate the Initiative's success.
- You accept that Fonterra may receive a rebate or commission from vendor partners participating in the Initiative. Any rebate or commission received by Fonterra from vendor partners will be allocated back to the Funding pool to benefit farmers participating in the Initiative. Any solution discount that may be negotiated between Fonterra and a vendor as part of the Initiative will be applied directly to your vendor's invoice for that solution rather than being reimbursed by Fonterra via the Funding on your monthly milk statement. You acknowledge that solution rebates, commissions or discounts are prospective only, and Fonterra makes no representation or guarantee that these will be available as part of the Initiative.
- Fonterra reserves all rights to decline an application, withdraw or terminate Funding, or seek repayment of the Funding, at any time where it knows or reasonably believes:
 - there has been abuse or attempted abuse of the Initiative or the Funding;
 - there has been a breach of these terms and conditions, or any applicable vendor terms and conditions (this includes if you fail to achieve any level of the Co-operative Difference in the 2025/26 season after you have received Funding);
 - o any behaviour relating to misconduct, theft or abuse, or supplying false or misleading information; or
 - you have not contacted the vendor and the vendor has used reasonable endeavours to contact you for onboarding, and your booking has not been completed with the vendor by 30 November 2025.

These Funding terms and conditions may be updated, amended or withdrawn by Fonterra at any time on reasonable notice to eligible participants.

		You are required to supply Fonterra with an itemised receipt/invoice and a photo of the planted vegetation purchased in the 2025/26 season (i.e. June 1, 2025 – May 31, 2026) for Fonterra to verify and reimburse you via your milk cheque.	
		There is an expectation that appropriate preparation, ongoing maintenance and pest control will be your responsibility.
